

## NOTICE OF STREET VACATION

Public notice is hereby given that on Tuesday, the 12th day of June, 2018, the City Council of the City of Long Beach, California, did at its regularly held meeting on said day, adopt Resolution of Intention No. RES-18-0080 declaring its intention to order the following vacation to be made pursuant to the provisions of the Public Streets, Highways and Service Easements Laws (California Streets and Highways Code), to wit:

THAT PORTION OF TRACT NO. 11340 FILED IN BOOK 203, PAGES 11 AND 12, OF MAPS IN THE CITY OF LONG BECH, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AND BEING THE EASTERLY 30 FEET OF ATLANTIC PLAZA AS SHOWN ON SAID MAP, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 2 IN BLOCK 4 OF SAID MAP:

THENCE SOUTH 00 DEGREES 16' 55" WEST A DISTANCE OF 300.00 FEET;  
THENCE NORTH 89 DEGREES 43' 05" WEST A DISTANCE OF 30.00 FEET;  
THENCE NORTH 00 DEGREES 16' 55" EAST A DISTANCE OF 300.00 FEET;  
THENCE SOUTH 89 DEGREES 43' 05" EAST A DISTANCE OF 30.00 FEET  
TO THE POINT OF BEGINNING.

RESERVING AN EASEMENT FOR PUBLIC ACCESS AND UTILITY PURPOSES OVER THE NORTHERLY, EASTERLY AND SOUTHERLY 10.00 FEET THEREOF. PUBLIC ACCESS AND UTILITY EASEMENT IS 3,400 SQUARE FEET OR 0.078 ACRES, MORE OR LESS.

The above described parcel of land contains 9,000 square feet, more or less. Subject to all matters of record, if any.
