EXEMPTION FROM FELINE RABIES VACCINATION

The following steps need to be completed to apply for a feline rabies vaccination exemption

1. Cat Owner completes "Owner and Cat Information" sections of this (1) form:
 - a. ACS Exemption from Feline Rabies Vaccination form
2. Veterinarian completes "Veterinarian Information" section of this form, including copies of supporting medical records.
3. Cat owner submits this form, including medical documentation, to City of Long Beach, Animal Care Services for review.
4. Local Health Officer, or designee, reviews form and supporting medical documentation for approval or denial of one year rabies vaccination exemption.
5. Owner contacted regarding exemption status.

I affirm that I am the owner of the cat indicated above. If this exemption **Microchip#:** _____ request is approved by the local health officer, I understand that the cat:

- a) will not receive the anti-rabies vaccine and will be at risk for contracting rabies;
- b) will be considered unvaccinated and subject to disposition as outlined in the City of Long Beach Municipal Code 6.12.110 , including isolation and/or euthanasia, if it bites a person or has contact with a known or suspected rabid animal;
- c) may be licensed for a period up to one year, at which time the cat must be vaccinated against rabies or a request for vaccination exemption must be resubmitted to and approved by the local health officer;
- d) shall have no contact with any dog or cat that is not currently vaccinated against rabies.

I understand the consequences and accept all liability associated with owning a cat that has not received the canine anti-rabies vaccine. I hereby request an exemption from rabies vaccination for the cat indicated above. This deferment shall be valid for a maximum period of one (1) year from the date of this certificate, at which time the condition of this animal must be re-evaluated or the inoculation administered.

In addition to the written, dated and signed statement of the licensed veterinarian, this deferment shall be approved by the authority of the local Health Officer or designee.
