Feb 2, 2026 <i>Semi-Annual</i>	* – 12/31/25	460 or 470	<ul style="list-style-type: none"> ▪ All committees must file this report. ▪ 470: If a candidate raised or spent less than \$2,000 during 2025, file Form 470 (see below). ▪ The January 31 deadline falls on a Saturday, so the deadline is extended to the next business day.
Within 24 Hours <i>Contribution Reports</i>	Ongoing – file any time other than 90-day election cycle	497	<ul style="list-style-type: none"> ▪ File if a contribution of \$1,000 or more in the aggregate is received from a single source. ▪ File if a contribution of \$1,000 or more in the aggregate is made to or in connection with a candidate or ballot measure being voted on the June 2, 2026, ballot or made to a political party committee. ▪ The recipient of a non-monetary contribution of \$1000 or more in the aggregate must file a Form 497 within 48 hours from the time the non-monetary contribution is received. ▪ E-file only. No paper copy is required.
Apr 23, 2026 <i>1st Pre-Election</i>	1/1/26 – 4/18/26	460 or 470	<ul style="list-style-type: none"> ▪ Each candidate listed on the ballot must file Form 460 or Form 470 (see below). ▪ E-file only. No paper copy is required.
May 21, 2026 <i>2nd Pre-Election</i>	4/19/26 – 5/16/26	460	<ul style="list-style-type: none"> ▪ All committees must file Form 460. ▪ E-file only. No paper copy is required.
May 29, 2026 <i>3rd Pre-Election</i>	5/17/26 – 5/27/26	460	<ul style="list-style-type: none"> ▪ All committees must file Form 460. ▪ E-file only. No paper copy is required.
July 31, 2026 <i>Semi-Annual</i>	5/28/26 – 6/30/26	460	<ul style="list-style-type: none"> ▪ All committees must file unless the committee filed termination Forms 410 and 460 before June 30, 2026. ▪ E-file only. No paper copy is required.

Additional Notes:

- *** Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Local Ordinance:** Always check whether additional local rules apply. [LBMC 2.01.720](#) requires the filing of an additional pre-election filing.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to the deadline for the Form 497 that is due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week. Statements filed after the deadline are subject to a \$10 per day late fine.
- **Method of Delivery:** The Office of the City Clerk asks all filers to submit digitally, via the online [eCampaign](#) portal or email CampaignDocs@longbeach.gov. If you are unable to file electronically, please file by personal delivery or first-class mail unless otherwise noted. A paper copy of a report may not be required if a local agency requires online filing pursuant to a local ordinance.

Additional Notes Continued:

- **Form 501:** All candidates must file Form 501 (Candidate Intention Statement) before soliciting/receiving contributions.
- **Form 460:** Candidates who have raised or spent \$2,000 or more file the Form 460. The Form 410 (Statement of Organization) must also be filed once \$2,000 or more has been raised or spent.
- **Form 470:** Candidates who do not raise or spend \$2,000 or more (or anticipate raising or spending \$2,000 or more) by the first pre-election filing and do not have an open committee may file Form 470. If, later during the calendar year, the candidate raises or spends \$2,000 or more, a Form 470 Supplement and a Form 410 must be filed.
- **Independent Expenditures:** Committees making independent expenditures totaling \$1,000 or more to support or oppose other candidates or ballot measures also file:
 - [462](#): This form must be e-mailed to the FPPC within 10 days.
 - [496](#): This form is due within 24 hours if made in the 90-day, 24-hour reporting period of the candidate's or measure's election. Refer to the applicable filing schedule. Form 496 is filed with the filing officer in the jurisdiction of the affected candidate or measure.
- **After the Election:** Reporting requirements will depend on whether the candidate is successful and whether a campaign committee is open. See [Campaign Disclosure Manual 2](#) for additional information.
