This serves as the City of Long Beach Harbor Department's (Port of Long Beach) Notice of Intent to adopt an Initial Study/Mitigated Negative Declaration (IS/MND) for the proposed Toyota Logistics Services (TLS) Improvement Project prepared in accordance with the California Environmental Quality Act (CEQA) and State CEQA Guidelines. The IS/MND evaluates the potential impacts of the proposed project on the existing environment, and measures, if necessary, to mitigate potential impacts to below significance thresholds. Per Section 15087(c)(6) of the CEQA Guidelines, the proposed project is not on any of the lists enumerated under Section 65962.5 of the California Government Code.

**Project Description:** TLS operates a marine terminal at the Port of Long Beach where new automobiles from Japan are off-loaded from ships, processed, and transported off-site via truck or rail. Toyota Motor Sales, USA, Inc. is proposing to reconfigure the existing TLS facility to streamline daily operations by demolishing approximately 223,200 square feet of existing process facilities and constructing a new consolidated replacement facility of approximately 167,372 square feet, including a 13,600-square-foot fuel-cell power plant and hydrogen fuel dispensing station.
