ORDINANCE NO. ORD-21-0015

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 21.37.120 AND SECTION 21.37.210; AND BY REPEALING THE ATLANTIC AVIATION CENTER PLANNED DEVELOPMENT DISTRICT (PD-13), ALL RELATING TO PLANNED DEVELOPMENT DISTRICTS AND SPECIFIC PLANS IN THE CITY OF LONG BEACH

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 21.37.120 of the Long Beach Municipal Code is amended to read as follows:

13. PD-13-Atlantic Aviation Center (repealed) (superseded by SP-3 Globemaster Corridor Specific Plan).

Section 2. Section 21.37.210 is amended to add a specific plan as follows:

3. SP-3-Globemaster Corridor.

Section 3. The Atlantic Aviation Center Planned Development District (PD-13) is hereby repealed in its entirety.


