3 AN ORDINANCE OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AMENDING THE USE DISTRICT
5 MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS
6 BEEN ESTABLISHED AND AMENDED BY AMENDING
7 PORTIONS OF PARTS 16, 17 AND 23 OF SAID MAP TO
8 REFLECT THE ESTABLISHMENT OF THE GLOBEMASTER
9 SPECIFIC PLAN

11 The City Council of the City of Long Beach ordains as follows:

12
13 Section 1. Environmental documentation having been prepared,
14 received, considered, approved, and certified as required by law, and the City Council
15 hereby finding that the proposed change will not adversely affect the character, livability
16 or appropriate development of the surrounding area and that the proposed change is
17 consistent with the goals, objectives and provisions of the General Plan, the official Use
18 District Map of the City of Long Beach, as established and amended, is further amended
19 by amending portions of Parts 16, 17 and 23 of said Map to rezone the subject parcels to
20 the Globemaster Specific Plan (SP-3).

21 Section 2. Those portions of Part 16, 17 and 23 of said Map that are
22 amended by this Ordinance are depicted on Exhibit "A" which is attached hereto and by
23 this reference made a part of this ordinance and the official Use District Map of the City.

24 Section 3. All ordinances and parts of ordinances in conflict herewith are
25 hereby repealed.

26 Section 4. The City Clerk shall certify to the passage of this ordinance by
27 the City Council and cause it to be posted in three conspicuous places in the City of Long
28 Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.
