

ORDINANCE NO. ORD-21-0041

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SECTION 1.27.010
SCHOOL BOARD DISTRICTS ESTABLISHED;
DECLARING THE URGENCY THEREOF; AND
DECLARING THAT THIS ORDINANCE SHALL TAKE
EFFECT IMMEDIATELY

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 1.27.010 of the Long Beach Municipal Code is hereby
amended to read as follows:

1.27.010 Districts established.

In accordance with Section 2202(a) of the Long Beach City Charter,
the five (5) school board districts for the board of education of the Long
Beach Unified School District (hereinafter "school district") are established
and designated as follows:

District 1:

BEGINNING AT THE INTERSECTION OF GREENLEAF BOULEVARD
AND EAST ROAD

Easterly along the LBUSD boundary to Downey Avenue

Southerly along the LBUSD boundary to South Street

Westerly along the LBUSD boundary to Cherry Avenue

- 1 Southerly along the LBUSD boundary to Market Street
- 2 South on Cherry Avenue to Pacific Union Railroad Right of Way
- 3 West along Pacific Union Railroad Right of Way to Orange Avenue
- 4 South on Orange Avenue to Carson Street
- 5 East on Carson Street to Cherry Avenue
- 6 South on Cherry Avenue to Wardlow Road
- 7 West on Wardlow Road to Linden Avenue
- 8 North on Linden Avenue to 36th Street

1 North on Cherry Avenue to the LBUSD Boundary
2 Easterly, then Northerly along the LBUSD Boundary to South Street

4 Section 2. This ordinance is an emergency ordinance duly adopted by
5 the City Council by a vote of five of its members and shall take effect at 12:00 a.m. on
6 December 7, 2021. The City Clerk shall certify to a separate roll call and vote on the
7 question of the emergency of this ordinance and to its passage by the vote of five
8 members of the City Council of the City of Long Beach, and cause the same to be posted
9 in three conspicuous places in the City of Long Beach.
10

11 Section 3. This ordinance shall also be adopted by the City Council as a
12 regular ordinance, to the end that in the event of any defect or invalidity in connection
13 with the adoption of this ordinance as an emergency ordinance, the same shall,
14 nevertheless, be and become effective on the thirty-first (31st) day after it is approved by
15 the Mayor. The City Clerk shall certify to the passage of this ordinance by the City
16 Council of the City of Long Beach and shall cause the same to be posted in three (3)
17 conspicuous places in the City of Long Beach.
