NOTICE OF PUBLIC HEARING

The City of Long Beach will conduct a public hearing on September 5, 2017 at 5:00 p.m. in the City Council Chambers at 333 West Ocean Blvd., Long Beach, California, 90802 to consider the adoption of new and/or adjusted fees designed to recoup all or a portion of costs associated with a specific City service.
