Approval(s) Requested: Zoning Code and Local Coastal Program Amendments

Proposed Project: The City currently has a moratorium relating to the establishment, installation, placement, construction, expansion or issuance of permits for the use of unattended donation/recycling collection boxes in the City. The proposed Zoning Code Amendment will adopt new standards by adding provisions relating to the regulation of Unattended Donation Boxes (UDBs), specifically adding Unattended Donation Box to the list of definitions and use tables within Long Beach Municipal Code Chapter 21.15 and Sections 21.32, 21.34 and 21.51.294. The Planning Commission, at a public hearing on January 4, 2018, recommended that the City Council adopt the proposed ordinance. The City Council will hear all public testimony for and against the proposed amendment, and will act on the proposed amendment. The City Council's action will be final.

Environmental Review: Pursuant to the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, a Negative Declaration (ND) has been prepared for the project and finds that the project would not have any potential significant adverse environmental impacts. The ND (10-17) was circulated for a 30-day public review period between November 14, 2017 and December 13, 2017. The ND is on file and available for review at the City of Long Beach Development Services Department, Planning Bureau, 333 West Ocean Boulevard, 4th Floor, Long Beach, CA 90802, during business hours Monday through Friday from 7:30 a.m. to 4:30 p.m. and on the City's website at: http://www.lbds.info/planning/environmental_planning/environmental_reports.asp

This project also includes an amendment to the Local Coastal Program for areas in the Coastal Zone, and is subject to certification by the California Coastal Commission.
