3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH IN SUPPORT OF PROPOSITION  
5 22, THE LOCAL TAXPAYER, PUBLIC SAFETY AND  
6 TRANSPORTATION PROTECTION ACT OF 2010  
7

8 WHEREAS, California voters have repeatedly and overwhelmingly passed  
9 separate ballot measures to stop State raids of local government funds, and to dedicate  
10 the taxes on gasoline to fund local and state transportation improvement projects; and

11 WHEREAS, these local government funds are critical to provide the police  
12 and fire, emergency response, parks, libraries, and other vital local services that  
13 residents rely upon every day, and gas tax funds are vital to maintain and improve local  
14 streets and roads, to make road safety improvements, relieve traffic congestion, and  
15 provide mass transit; and

16 WHEREAS, despite the fact that voters have repeatedly passed measures  
17 to prevent the State from taking these revenues dedicated to funding local government  
18 services and transportation improvement projects, the State Legislature has seized and  
19 borrowed billions of dollars in local government and transportation funds in the past few  
20 years; and

21 WHEREAS, State politicians in Sacramento have continued to ignore the  
22 will of the voters, and current law provides no penalties when state politicians take or  
23 borrow these locally-dedicated funds; and

24 WHEREAS, a coalition of local government, transportation and transit  
25 advocates filed a constitutional amendment with the California Attorney General, called  
26 the Local Taxpayer, Public Safety, and Transportation Protection Act of 2010, which will  
27 be on the November 2010 statewide ballot as Proposition 22; and

28 WHEREAS, approval of this ballot initiative would close loopholes and

1 change the constitution to further prevent State politicians in Sacramento from seizing,  
2 diverting, shifting, borrowing, transferring, suspending or otherwise taking or interfering  
3 with tax revenues dedicated to funding local government services, including  
4 redevelopment, or dedicated to transportation improvement projects and mass transit;

5 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
6 follows:

7 Section 1. The City Council of the City of Long Beach formally endorses  
8 Proposition 22, the Local Taxpayer, Public Safety and Transportation Protection Act of  
9 2010, a proposed constitutional amendment.

10 Section 2. The City Council of the City of Long Beach hereby authorizes  
11 the listing of the City of Long Beach in support of Proposition 22, the Local Taxpayer,  
12 Public Safety and Transportation Protection Act of 2010.

13 Section 3. This resolution shall take effect immediately upon its adoption  
14 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
