Past and Ongoing Events

LB Proclaims Homelessness Emergency

On Tuesday, City Council, on a unanimous vote, adopted the City Manager's proclamation of a local homelessness emergency. On Wednesday, the Emergency Operations Center (EOC) was activated and initial staffing was determined to support the emergency. Yesterday, the City Manager released a mission statement that reflects City Council input from Tuesday's meeting. It reads: *The City's stated mission is to reduce the number of*



people experiencing homelessness in the City and the region by increasing housing opportunities and by enhancing current initiatives that provide field-based outreach, engagement, and supportive services while maintaining the safety and security of the people experiencing homelessness, the general public and staff, and address and improve overall public safety for the entire community. Stearns Park Water Well Project Update

Drilling has concluded at the Alamitos 9A site of the Stearns Park groundwater well project, located at 23rd Street and E. De Ora Way. The drill rig is scheduled to be moved and the sound wall dismantled this month. Work will soon begin at the second well site, Alamitos 14, located just north of the community center. As the drilling phase of construction winds down, the wells will be prepared for pumping groundwater. Proposed renderings of the landscaping

(see below & right) show how the sites will look once the plants mature. The design was based on input and suggestions received from neighbors at community meetings. 

And Finally....

Park Circle Homes... Then and Now

In last week's "And Finally" feature, we talked about the open space that existed along the Atherton Corridor between Clark Avenue and Outer Circle. There were housing developments on all sides of the the area bordered by Clark, PCH and Los Coyotes Diagonal, but there was no housing in the middle. That changed in 1949 when developer Mark Taper (as in Mark Taper Forum) built 65 single-family homes on Park Ave between

Atherton and PCH. The "Park Circle Homes" newspaper ad on November 6, 1949 stated the twobedroom homes were \$8,300, and the three-bedroom homes were \$9,500. Vets could move in without a down payment, and monthly payments were as low as \$52.

What was not mentioned in the ad was the large size of many of the lots. As you can see in the 1952 aerial photo below, the lots nearest Atherton were incredibly deep by Los Altos standards. That may have been a factor that determined the fate of the neighborhood. Those lots became very attractive to multi-unit housing developers, and that is exactly what happened. Most of the single-family homes were converted to apartment buildings, and the housing density grew by over 600%. The original 65 single-family units became a whopping 395 multi-family units!

















Count Groups by Street
