


REPORTABLE DISEASES AND CONDITIONS


Title 17, California Code of Regulations (CCR) §2500


It shall be the duty of every health care provider, knowing of or in attendance on a case or suspected case of any of the diseases or condition listed below, to report to the local health officer for the jurisdiction where the patient resides. "Health care provider" encompasses physicians (surgeons, osteopaths, oriental medicine practitioners), veterinarians, podiatrists, physician assistants, registered nurses (nurse practitioners, nurse midwives, school nurses), infection control professionals, medical examiners/coroners, dentists, and chiropractors, as well as any other person with knowledge of a case or suspected case.

This list is specific to Long Beach and may differ from state and federal reporting requirements.

URGENCY REPORTING REQUIREMENTS

 **Report immediately by telephone**

 **Report by Fax or Email within 1 working day**

 **Report within 7 calendar days from time of identification**









HIV REPORTING BY HEALTH CARE PROVIDERS §2641.5-2643.20

Human Immunodeficiency Virus (HIV) infection is reportable by traceable mail or person-to-person transfer within seven calendar days by completion of the HIV/AIDS Case Report form (CDPH 8641A) available from the local health department.
