Our project provides 51 CoC funded DV beds in Long Beach; at full capacity, 51 participants reside in 15 low-barrier, trauma-informed transitional housing units. Clients represent all cultures, ages, races, religions, sexual orientations, abilities, ethnicities, family sizes (with children ages 0-17), pregnant women (before/after birth) and survivors with co-occurring challenges (disability, mental illness and substance use). We use Housing-First/Harm-Reduction Principles to include, but not to exclude, participants in our program. Housing types and services are voluntary, client directed and focused on securing permanent housing (PH) as quickly and safely as possible. We offer supportive services, case management, benefits linkages (SSI/SSDI), licensed mental health services, life skills, income enhancement, legal services and substance use education to create future housing stability. At entry, clients receive individual service plans for services either within our organization or via referrals to service partners who address needs after PH transition. The project leverages external resources like local schools, social services, and youth organizations. We have leveraged County, State, Federal, and private funds to operate this project. CoC funding sustains project services including confidential, trauma-informed shelter care and population-specific interventions (e.g., legal services) that are coordinated with CoC/CES PH resources.



Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.



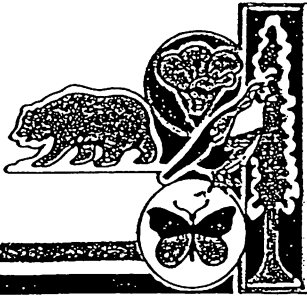

A California Nonprofit Public Benefit Corporation

I. NAME

The name of the corporation is 1736 FAMILY CRISIS CENTER.

II. PURPOSES

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, and the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law.

(b) All corporate property is irrevocably dedicated to the purposes set forth in Article Two, above. No part of the net earnings of this corporation shall inure to the benefit of any of its directors, trustees, officers, private shareholders or members, or to individuals.

(c) On the winding up and dissolution of this corporation, after paying or adequately providing for the debts, obligations, and liabilities of the corporation, the remaining assets of this corporation shall be distributed to such organization (or organizations) organized and operated exclusively for charitable purposes, which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States internal revenue law).



