The 2023 Long Beach Homeless PIT Count estimated 3,447 unhoused individuals, a 4.6% increase since the 2022 count. To help relieve homelessness in the community, PATH's Family Commons project serves as a PSH for 40 homeless families, each with at least one member with a documented disabling condition. Located in the Villages at Cabrillo, Family Commons offers tenants supportive services to improve their wellness and selfsufficiency. Case managers work with families to help them identify needs and connect to on- or off-site resources to increase household income; improve job opportunities; and equip families with parenting, conflict resolution, and more. Tenants can access additional services from 14 on-site nonprofit providers. Family Commons pairs a low-barrier, Housing First approach with evidencebased practices (e.g., harm reduction, trauma-informed care, critical time intervention) to help tenants maintain housing without required participation. Case managers encourage families to access ongoing education and services to strengthen their physical, economic, and emotional well-being. Family Commons also provides enrichment activities to youth tenants to help reintegrate them into the community and build resiliency. This letter is in response to your telephone call of December 9, 2002, requesting a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in February 1985, granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

ARTICLES OF INCORPORATION OF

Michael J. Goldberg and Eva G. Vollmer certify that:

- 1. They are the co-chairman of the board and the secretary, respectively of P.A.T.H., a California nonprofit public benefit corporation.
- 2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

ARTICLE I

The name of this corporation is PATH.

ARTICLE II

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.
- B. The specific purposes of this corporation are to provide housing and/or support services for families and adults who are homeless or at risk of becoming homeless.
- C. This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Internal Revenue Code"), or the corresponding provision of any future United States revenue law.
- D. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its public and charitable purposes, and the corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Internal Revenue Code Section 501(c)(3) or the corresponding provision of any future United States internal revenue law, or (b) a corporation, contributions to which are deductible under Internal Revenue Code Section 170(c)(2) or the corresponding provision of any future United States internal revenue law.

ARTICLE III

A. This corporation shall have one member and that member shall be PATH Partners, a California nonprofit public benefit corporation.

B. The corporation shall dissolve whenever its charter is surrendered to, taken away by or revoked by the member.

ARTICLE IV

- A. No substantial part of the activities of this corporation shall consist of lobbying or propaganda, or otherwise attempting to influence legislation; this corporation shall not participate or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any political campaign on behalf of any candidate for public office.
- B. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- C. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to PATH Partners, a corporation which is organized and operated exclusively for charitable, scientific, literary, or educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code (or any corresponding provision of any future United States Internal Revenue Laws).
- 3. The foregoing amendment and restatement of the Articles of Incorporation has been duly approved by the board of directors.
 - 4. The corporation has no members.
