

LETTER OF AGREEMENT
CITY OF LONG BEACH AND LONG BEACH MANAGEMENT ASSOCIATION
(LBMA)

RE: SICK LEAVE FOR SEASONAL AND TEMPORARY NON-CAREERS

This Letter of Agreement is entered between the City of Long Beach (“City”) and the Long Beach Management Association hereinafter called “LBMA” (collectively “the Parties”).

WHEREAS, effective on January 1, 2024, Sick Leave for Seasonal and Temporary Non-Career employees increased under Senate Bill 616 from 24 hours or 3 days, to 40 hours or 5 days annually. The City elected to issue the full amount of paid sick leave required under the law, at the beginning of each calendar year. Unused sick leave does not carryover from one year to the next. Newly hired Seasonal and Temporary Non – Career employees are issued the full amount of paid sick leave required under SB 616 on the date of hire and are able to use the full amount of their accruals on the 90th day of employment.

WHEREAS, effective January 1, 2025, the City will provide an additional 8 hours, increasing the advanced Sick Leave hours for Seasonal and Temporary Non-Career Employees from 40 hours to 48 hours.

NOW THEREFORE, the Parties agree to amend the 2023-2026 LBMA MOU by adding a provision under Article Three, Section V regarding Sick Leave for Seasonal and Temporary Non-Career employees as follows:

Sick Leave

1. Permanent, full-time employees covered by this MOU shall earn a maximum of twelve (12) days [ninety-six (96) hours] of sick leave per year, with unlimited accrual.

2. In addition to the usage of sick leave accruals, when an employee is personally ill or disabled, the employee shall be entitled to use any available earned sick leave accruals for an absence from duty for personal medical appointments or to attend to their ill, or injured child (of any age), parent, spouse, domestic partner, parent-in-law, grandparent, grandchild, siblings, or a designated person, in accordance with the California Family Rights Act (CFRA).
3. Catastrophic Leave donations for eligible employees will only be allowed in circumstances where an employee has exhausted all available leave accruals, and are no longer covered by STD or LTD, if applicable, whether the donations are requested to cover a personal or family related illness.

4. In addition to the five days (40 hours) required pursuant to SB 616, Seasonal and Temporary Non-Career employees will be advanced an additional 8 hours, totaling 48 hours of paid sick leave per calendar year. Newly hired Seasonal and Temporary Non-Career employees will be able to use the full amount of their Sick Leave on the 90th day of employment, and in subsequent years of employment they shall be credited Sick Leave at the beginning of the calendar year. Unused Sick Leave will not carryover from one year to the next.
5. Employees are entitled to use any available Sick Leave hours for diagnosis, care or treatment of a health condition, or for an employee who is the victim of domestic violence, sexual assault or stalking, or can be used to cover absences taken for doctor or dental appointments, bereavement leave, reproductive loss leave or to care for an eligible family member's illness, or a 'designated person', as defined by state and/or federal law.
6. Permanent Full-Time, Permanent Part-Time and Seasonal and Temporary Non- Career Employees are entitled to use any available Sick Leave hours for diagnosis, care or treatment of a health condition, or for an employee who is the victim of violence (i.e. domestic violence, sexual assault or stalking), or can be used to cover absences taken for doctor or dental appointments, bereavement leave, reproductive loss leave or to care for an eligible family member's illness, or a 'designated person', as defined by state and/or federal law.
7. Permanent Full-Time, Permanent Part-Time and Seasonal and Temporary Non- Career Employees may not be terminated or retaliated against for using or requesting the use of issued paid sick leave.
8. Employees may not be terminated or retaliated against for using or requesting the use of issued paid sick leave.

This Letter of Agreement shall not change any Memorandum of Understanding provisions other than as outlined above.
