- Building Standards Code ("Codes") are laws governing the construction of residential and nonresidential buildings and structures.
- Every 3 years the codes are updated by the State.
- CA HSC Sections 17958, 18941.5, and 13869
- State Agencies (i.e. CBSC, HCD, DSA, SFM, etc.)
- California Building Standards Commission (CBSC) is responsible for the administration and implementation of each code cycle.





- CBSC adopted the 2025 Codes on or around January 1, 2025
- Codes to be published by July 1, 2025
- Codes take effect 180 days after on January 1, 2026
- City is mandated by State law to adopt the Codes
- City may amend the Codes to address local issue
- Amendments to "Building Standards" need to be justified on the basis of local geologic, topographic, climatic or environmental conditions





- Amendments must generally be more restrictive, not less
- Amendments to "Administrative Standards" does not require justification
- BEAC assist the Building Official as an advisory body to recommend the adoption of the Codes and local amendments to the City Council (CC)
- BEAC meetings serves as a public forum to allow input and feedback by stakeholders





- Public hearing at the CC meetings to consider a citywide Ordinance and Resolution to adopt the Codes and local amendments (October 21, 2025)
- File Ordinance and Resolution with the CBSC
- Adopted Codes becomes effective January 1, 2026
- All projects submitted prior to January 1, 2026 are subject to the previously adopted Codes
- All projects submitted on or after January 1, 2026 are subject to the newly adopted Codes

# **Updates included by State Agencies**

- Update of all CA Codes
- Update to Building Energy Efficiency Requirements
- Relocation of Wildland-Urban Interface (WUI) requirements to standalone Part 7 of CCR Title 24
- Generally minor revisions this adoption cycle





# **Updates under consideration by the City**

- Administrative changes in Chapters 18.01 18.30 to reflect current practices and procedures that were not previously codified or needs update
- Re-adopt previously adopted amendments in Chapters 18.40 – 18.50 related to structural, fire-life safety and green provisions
- Add Chapter 18.51 to adopt California WUI Code





## **Updates under consideration by the City**

- Administrative (editorial) updates to Chapters
   Chapters 18.40 through 18.51 to address adoption of 2025 California Building Standards Codes
  - Includes updating references and minor language changes but generally not technical changes





# **Updates under consideration by the City**

- Update and improve Chapter 18.78 for Construction Near Abandoned Oil Wells to clarify requirements
- Update Chapter 18.76 to include streamlined permitting process for hydrogen fueling stations





## **Updates under consideration by the City - Separate Ordinances**

- Adoption of the International Property Maintenance Code
- Adoption of an Energy (electrification) Reach Code
- Building Seismic Resiliency Program
  - Voluntary Strengthening of Soft, Weak, or Open-Front Buildings





# **Recommendation to the City Council**

- Declare the Ordinance adopting and amending the 2025 California Building Standards Code and the 1997 Uniform Housing Code (or 2024 IPMC) by amending Title 18 of the LBMC
- Adopt a Resolution making findings and determinations relating to the adoption of more restrictive Building Standards Code provisions, where appropriate

#### LONG BEACH MUNICIPAL CODE (LBMC)

- This presentation is intended to focus on the bulk of this process
- These items are unchanged, or amended without changing the content





#### LONG BEACH MUNICIPAL CODE (LBMC)

- LBMC Title 18 Long Beach Building Standards Code
- Amendments are proposed by the Building and Safety Bureau
- Amendments at future BEAC meetings may be proposed by the Department of Public Works, Fire Prevention, Code Enforcement Bureau, Planning Bureau, and Building and Safety Bureau
- Administrative and Editorial Changes
- Continuation of amendments previously adopted
- Substantive changes will be presented at April BEAC meeting





#### **GENERAL FINDINGS**

- Administrative Changes
  - These are minor changes that do not impact the content of the existing LBMC section
  - Includes change of references to the 2025 Codes
- Editorial Changes
  - These are minor changes that do not impact the content of the existing LBMC section
  - Includes language clean-up, spelling corrections, and revisions to mirror the updated model code language

(Specific findings for the items discussed can be found in the supporting documentation)





#### LONG BEACH MUNICIPAL CODE (LBMC)

- "Track Changes" are used in this presentation and the supporting documents to indicate where alterations to existing text
- Strikeout is used for deletions from existing text
- <u>Underline</u> is used to indicate insertions into existing text
- Amendments may show up in blue, purple or red
- There is no significance to the color, just indicates a different editor





#### LONG BEACH MUNICIPAL CODE (LBMC)

• The following is an example of "Track Changes". The text shown in black is existing and colored text (red in this case) represents the alterations.

This is an example of to show the use of strikeout and underline "Track Changes." This MS Word feature is used to clearly show changes alterations to the original text. New text or added sections are shown completely as underlined. The final documents presented to City Council for approval will not include "track changes."

#### SECTIONS WITHOUT CHANGES OR EDITS

  - 18.01 thru 18.04, 18.15 thru 18.21, 18.24, 18.25, 18.29, 18.30, 18.40 thru 18.44, 18.46 thru 18.51, 18.68, 18.78, 18.99
  - Any future specific amendments to these chapters/sections resulting in content changes will be presented at a future BEAC meeting

  - 18.74 LOW IMPACT DEVELOPMENT STANDARDS
  - 18.75 GRADING, EXCAVATIONS AND FILLS
  - 18.76 STREAMLINED PERMITTING... for hydrogen fueling stations
  - 18.78 CONSTRUCTION IN THE VICINITY OF ABANDONED OIL WELLS
  - 18.XX SEA-RISE CONSTRUCTION STANDARDS
- A detailed presentation of these items will be given at a future BEAC meeting
