# INVESTING IN OUR COMMUNITIES

Due to its large population, Long Beach is an entitlement city that qualifies to receive HUD funding. The City of Long Beach, through its Community Development Department (LBCD) uses this funding for a variety of programs and services that help provide communities with better housing and suitable living environments. The funding is disbursed through three grant programs:

- **Community Development Block Grant (CDBG):**  
Provides funding for community development activities, including housing projects, youth programs, public infrastructure improvements and more.
- **Emergency Shelter Grant (ESG):**  
Funds programs that provide shelter and supportive services for individuals experiencing homelessness.
- **HOME Investment Partnership Program (HOME):**  
Funds the acquisition, rehabilitation and development of multi-unit affordable housing projects around the city to create and preserve affordable housing.



# PRIORITIZING COMMUNITY NEEDS

There are five main goals for the HUD funding:

1. Create and preserve affordable housing
2. Support activities to end homelessness
3. Eliminate blight and strengthen neighborhoods
4. Expand economic opportunities
5. Promote fair housing choice

## 2023-2027 Consolidated Plan

In order to receive HUD grants to help accomplish the five goals, the City must first develop a five-year Consolidated Plan. The Plan, which is developed through a collaborative process that includes input from residents, neighborhood groups, business owners and other stakeholders, assesses community development and housing needs and identifies the programs and services that are prioritized and funded by HUD grants.

## Annual Action Plan

Annual Action Plans provide a concise summary of the actions, activities, and specific federal and non-federal resources that will be used each year to address the priority needs and specific goals identified by the Consolidated Plan.

## Consolidated Annual Performance & Evaluation Report (CAPER)

The CAPER outlines the accomplishments made during each Annual Action Plan and the progress made toward the goals identified in the Consolidated Plan.
