The first of its kind in the United States, this joint Clean Air Action Plan describes various measures that the Ports of Long Beach and Los Angeles will take toward reducing emissions related to Port operations. On November 20, 2006, the ports of Long Beach and Los Angeles took an unprecedented joint action to improve air quality in the South Coast Air Basin by adopting the San Pedro Bay Ports Clean Air Action Plan (CAAP), a sweeping plan aimed at significantly reducing the health risks posed by air pollution from Portrelated ships, trains, trucks, terminal equipment and harbor craft.

The comprehensive [infrastructure, transportation, land-use and open space] plan proposes to create the second largest park in Long Beach while relocating impactful freight transportation away from the West Long Beach community by repurposing redundant and under-utilized infrastructure. This plan proposes to utilize significant investment for the area to reduce land-use conflicts and transportation impacts from nearby goods movement infrastructure and industrial uses while creating substantial public benefit. The plan has been developed with community, local stakeholders and government agency input.

The Healthy Communities Policy establishes a framework for developing each neighborhood in the City into a healthy, prosperous and livable community. Through interdepartmental collaboration, the Healthy Communities Policy will be the first step in developing the Healthy Long Beach Plan spearheaded by the City Health and Human Services Department.
