Proposed Project: The modification of an existing wireless telecommunication facility on a rooftop to allow the removal and replacement of six (6) antennas, three (3) RRU's, and one (1) equipment cabinet; removal of the (3) TMA's; installation of three (3) RRU's, and one (1) equipment cabinet in the equipment area, along with associated ancillary equipment upgrades to the leasing area to an existing site, and to find that this project is consistent with the certified Local Coastal Program, located at 5580 East 2nd Street in the Neighborhood Pedestrian (CNP) Zoning District (District 3).

This project **IS** in the Coastal Zone and **IS** appealable to the Coastal Commission.

There may be other time limits which also affect your ability to seek judicial review.
