- Proposed Project:** Replace approximately 3,000 linear feet of ductile iron pipes with PVC pipes below grade within the Spinnaker Bay Drive public right-of-way from the beginning of Spinnaker Bay Drive to Parsons Landing, and the following parallel streets: Casino Point, Descanso Bay, Long Point, Blue Cavern Point & Parsons Landing within the Southeast Area Development and Improvement Plan (PD-1) Zoning District. All surface excavation would be restored to a paved surface upon project completion. (District 3)

This project **IS** in the Coastal Zone and **IS** appealable to the Coastal Commission.

**Environmental Review:** This project qualifies for a categorical exemption per Section 15302 (Replacement and Reconstruction) of the California Environmental Quality Act Guidelines. (CE-21-047)

If you challenge this agenda item in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90<sup>th</sup> day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
