**Proposed Project:** Local Coastal Development Permit request to fund the rehabilitation of the Sewer Lift Station S-8 located at 6306 Marina Drive in the Park (P) Zoning District consistent with the certified Local Coastal Program. The project would ensure improved operations of the sewer system in the area. Work includes replacement of pumps, motors, piping, and associated structural, mechanical, and electrical components. The project scope includes improvement to the on-site wet well, construction of pipelines, and exhaust fan and ductwork. (District 3)

This project **IS** in the Coastal Zone and **IS** appealable to the Coastal Commission.

**Environmental Review:** This project qualifies for a categorical exemption per Section 15302 (Replacement or Reconstruction) of the California Environmental Quality Act Guidelines. (CE-21-037)

If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90<sup>th</sup> day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
