Proposed Project: Modification to an existing Local Coastal Development Program (Case No. 9810-13) for the demolition of an existing exterior staircase an installation of a new elevator and a new staircase leading to an existing deck at the Bay Shore Beach Concession Stand in the Park (P) Zoning District. The project includes the rehabilitation/replacement (as needed) of existing wood decking and the installation of a new wood deck walkway for an Americans with Disabilities Act (ADA) path of travel to the new elevator and existing deck areas. (District 3)

This project **IS** in the Coastal Zone and **IS** appealable to the Coastal Commission.

If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
