Proposed Project: An Administrative Use Permit to allow an on-site shared parking agreement between an existing church use (Sanctuary, fellowship hall, and office) and a converted commercial building (formerly accessory child care building) on an existing church site located at 370-390 Junipero Avenue in both the Institutional (I) and Commercial – Neighborhood Pedestrian (CNP) Zoning Districts (District 2).
