Project Location: 100 East Ocean Boulevard, Long Beach, CA 90802. The property is bounded by Ocean Boulevard to

the north, Pine Avenue to the west, Seaside Way to the south, and the Promenade South

Walkway/commercial building to the east.

Project Description: The project proposes a 30-story, 537,075-square-foot building of up to 375.5 feet in height that

would include 429 hotel rooms, 23,512 square feet of restaurant space, and 26,847 square feet of meeting and ballroom space. The proposed building would replace an existing surface parking lot on the Project Site. Pedestrian walkways and new landscaping would be provided. The project also includes improvements to the portion of Victory Park located within the Project Site boundaries,

including new landscaping and restoration of the Jergins Trust Tunnel.
