MESSAGE FROM THE BRIDGE



Happy Holidays to one and all, big and small, near and far, whoever you are. This November/December season brings many opportunities to celebrate with family and friends. I wish each and every one of you good tidings through this season and beyond. If you plan on having holiday festivities on your vessel this year have a great time but keep it safe and be mindful of your slip neighbors.

We have a lot going on in a short period of time to close out 2024. We just recently begun work to revitalize the parking lot at Shoreline Marina and Marina Green. Phase I of concrete improvements will last through December 23. Please keep an eye out for parking restrictions and plan accordingly. Parking and access will be maintained throughout construction but will be limited in areas during the project.

Beach Maintenance staff are prepping for King Tide events on November 15-17 and December 13-15. King tide events will continue to be a point of Climate Action address in regard to sea level rise and flooding impact for our City and coastal areas around the globe. However, it is also quite amazing to see this formidable natural process that is tidal surge. I recommend getting out a tide log or looking online for the highest tide point and coming down to Alamitos Bay or Shoreline to see a true "King" tide.

On Thanksgiving night our annual Trees in the Bay program will go illuminated. This year Marine Maintenance staff have transitioned every bulb on each tree platform from incandescent to LED. They are also working to deploy nine additional solar powered tree platforms into the Colorado Lagoon. While a baby step on the scale required to make significant emissions impact, our Marine Bureau staff is committed to implementing green initiatives and non-carbon power solutions everywhere we can. In addition to the solar tree platforms Marine Maintenance is working to convert our Landscape Maintenance staff office at Marine Stadium to solar power as well as the Marine Stadium Grandstand.

Marine Operations staff have continued to fill available slips in Alamitos Bay, Shoreline and Rainbow Marinas. As of mid-October we had a near 100% occupancy rate in Alamitos Bay. For available slips please contact the Marina Offices. Operations staff work seven days a week and are available to assist with all your Long Beach Marinas needs. Lastly, your Marina Offices continue to distribute 2025 parking passes and decals. Please make certain to get your passes and apply them properly to your vehicles. Marine Patrol will start citing in early 2025.

Marina Offices are open and accepting new vessel permit applications. To provide more comfortable and efficient customer service we have hybrid front desk/window service at ABM and Shoreline offices. Note – Many requests can still be readily handled by phone or email.

2025 Parking Passes – Marina offices are now distributing 2025 parking passes. Make sure to complete your information update form and pick up your 2025 passes before January 1, 2025.

Deposit Adjustment – Marina Fees increased on October 1, 2024. A one-time fee was also charged to balance slip deposits to the FY25 Marina Slip Fees. Check your Marina Account to make sure your deposit adjustment has been paid.

Unauthorized commercial activity is **ILLEGAL IN LONG BEACH** – Please do not engage in unauthorized commercial activity at, on or near Long Beach Marinas property. Violators can and will be cited and punished to the full extent of applicable law. Reminder – Unauthorized Commercial activity will put your slip permit in jeopardy of cancellation.

2025 PARKING PASSES REQUIRED



2025 parking passes and decals are currently available to all slip holders and permittees. Make sure you pick up your passes before the start of 2025. Passes and decals are available at the Marina Offices during regular business hours every day of the week. You are required to provide an updated boater information form to receive your 2025 parking passes and decals.

Current parking passes and decals are an integral aspect of the security of our marinas. Please make certain to display your passes in the proper location on your vehicle. Do not share or loan your parking passes or decals to others. If someone you know needs a parking pass or decal send them to the Marina Offices. Marina staff will explain or parking pass requirements and provide a pass, or passes, to individuals and groups in accordance with Long Beach Marinas Rules & Regulations and the Long Beach Municipal Code.

Marine Patrol will begin citing unauthorized vehicles without current parking passes and decals in early 2025. We are also putting a greater emphasis on identifying, citing and removing vehicles that are being stored in the parking lots longer than 72 hours in 2025. If you see suspicious vehicles in the Marina Parking lots, vehicles in boatowner parking without parking passes or decals, or vehicles parked and left unattended for extended durations, please reach out and report the vehicle(s) to Long Beach Marinas staff.

SHORELINE & MARINA GREEN PARKING LOT UPGRADES BEGIN



In early October contractors started Phase I of work to revitalize the parking lots at Shoreline Marina and Marina Green. Phase I construction will be coordinated in three areas between October and December. Area 1 concrete work was completed on October 29 and Area 2 work began on October 30. Area 2 work will run through November 27. On December 2, Area 3 work is set to commence and will run through December 23.

This construction will have impact on parking available for boatowners throughout the planned construction period. Please pay attention to signage at the construction location and check your email for communication from your Marina Office pertaining to construction schedules. This will include directional signage for temporary exit and entry restrictions, notice of no parking in areas and notice of available boatowner parking.

The project will include pavement rehabilitation, restriping of parking stalls, accessibility enhancements, new EV charging stations and optimized traffic flow with the addition of a turn-around at the northeast end of the Marina Green public parking area. KING TIDES MAKE THEIR RETURN



On November 15-17 King Tides will make their first seasonal appearance in the Southern California coastal areas. Our Long Beach area waterways will see higher than usual tidal surge that can cause flooding and property damage if not properly prepared for and monitored.

Long Beach Marinas maintenance staff will be hard at work in the weeks leading up to the November tide event as they build oceanfront and bayside berms on the Peninsula and in Alamitos Bay. We bring in additional heavy equipment to enlarge and reinforce existing berm structures on the Peninsula to withstand the elevated water levels. On the bayside between 55th Place and 64th Place crews will be erecting a temporary berm to keep water levels from reaching all the way up to the existing seawall. This is done for high tides that exceed 6'7".

The seawall on the bayside is built to hold back water levels higher than these King Tides are expected to bring. We build the bayside berms to keep the sand areas nearest the seawall free of water to every extent possible. This allows us to continue permitting Sandstake locations and distributing trash receptacles on the bayside beach for public use. Without the bayside berms for tide events over 6'7" we would unfortunately see Sandstake kayaks, canoes, paddleboards and sailboats floating unattended across the bay.

Prior to the King Tide event in November please check your Sandstake vessel(s) to confirm it is secured properly to the stake. If you have a vessel in a slip come down and inspect your dock lines and re-fasten lines that may be loose or providing too much slack.

November 15-17 is the first King Tide event of the season and will give way to another King Tide event on December 13-15. There is an opportunity to participate in the monitoring of King Tides with the California Coastal Commission via their California King Tides Project. 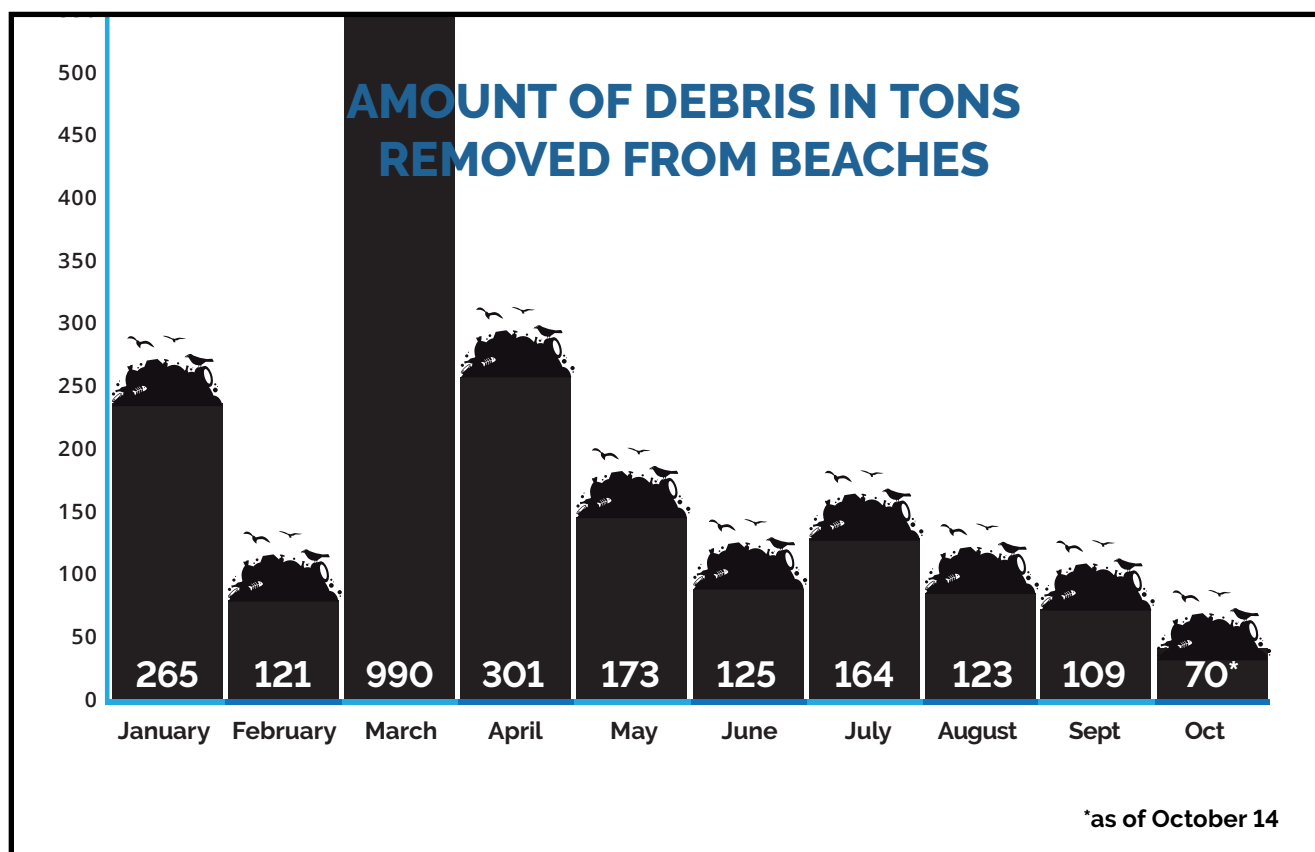

The Marine Advisory Commission (MAC) of Long Beach, California advises the City Council and staff on policies for marinas, beaches, waterways, and near shore areas. The MAC's mission is to:

- Advise: Consult with the City Council and staff on matters related to city policies
- Analyze: Study and analyze problems referred to by the City Council and staff
- Recommend: Evaluate and recommend policy to the City
- Hear appeals: Conduct hearings for appeals of permit cancellations
- Analyze requests: Analyze requests from individuals or groups and make recommendations
- Report annually: Present an annual written report of the MAC's activities to the Mayor and City Council

Area 1: October 14 - October 30, 2024

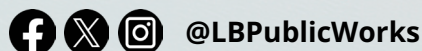
Area 2: October 30 - November 27, 2024

**Construction timeline is set barring unforeseen weather changes or other circumstances.*

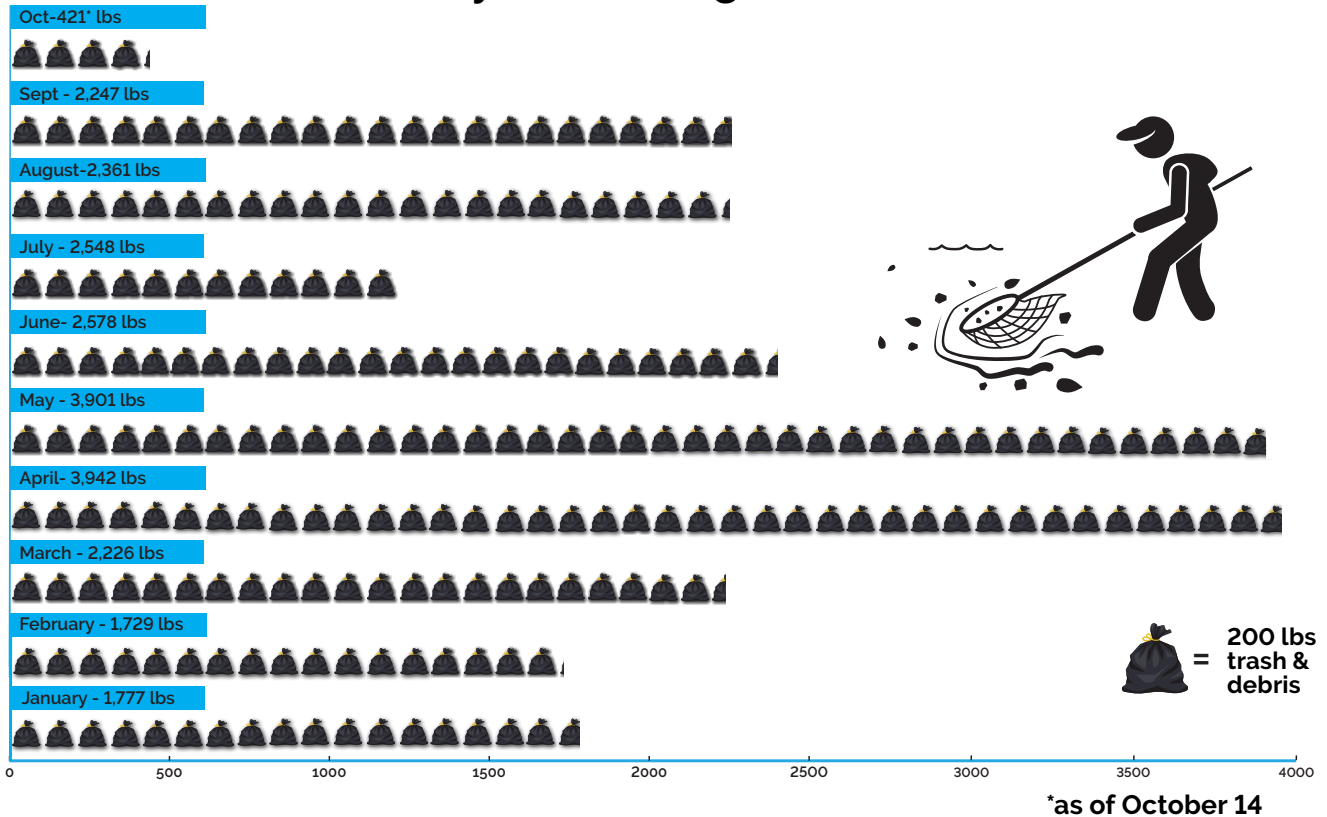
