ISLAND WHITE RULES & REGULATIONS:

MOORING/ANCHORING ONLY BETWEEN 10AM – 3PM MONDAY THROUGH THURSDAY.
OVERNIGHT MOORING/ANCHORING ONLY ON FRIDAY, SATURDAY, SUNDAY. MUST VACATE MOORING/ANCHORING BY 3PM MONDAY.
OVERNIGHT MOORING/ANCHORING LIMITED TO TWO WEEKENDS PER CALENDAR MONTH.
MOORED/ANCHORED VESSEL(S) MUST HAVE AN INDIVIDUAL ABOARD AT ALL TIMES.
MOORED/ANCHORED VESSEL(S) MUST BE SECURED WITHIN 400 YARDS OF ISLAND WHITE ON THE NORTHSIDE OF THE ISLAND.
MOORED/ANCHORED VESSEL(S) MUST HAVE CURRENT REGISTRATION DOCUMENTS AND PROOF OF INSURANCE.
VESSEL(S) MUST NOT EXCEED 5MPH WITHIN 200 FEET OF ANCHORED/MOORED VESSELS
LONG-TERM MOORING AVAILABLE - RESERVATION THROUGH CITY OF LONG BEACH APPROVED VENDOR REQUIRED.
CITY APPROVED VENDOR - BELMONT MOORING COMPANY

MUNICIPAL CODES:

"NEARSHORE OCEAN AREA" MEANS THAT PORTION OF THE PACIFIC OCEAN WITHIN THE LIMITS OF THE CITY SHOREWARD OF A LINE EXTENDING NORTHWESTERLY FROM LIGHT "1" OF THE ALAMITOS BAY WEST JETTY TO THE SOUTHERN MARKER LIGHT ON ISLAND WHITE, THENCE WESTERLY TO THE STERN OF THE QUEEN MARY. 16.12.080

NO PERSON SHALL ANCHOR, MOOR, TIE OR OTHERWISE KEEP OR MAINTAIN ANY VESSEL, RAFT, BARGE OR FLOAT WITHIN THE NEARSHORE OCEAN AREA EASTERLY OF THE LINE DESCRIBED IN SECTION 16.12.070 WITHOUT A PERMIT ISSUED BY THE DIRECTOR. 16.12.160B

NO PERSON SHALL DIVE, PLUNGE OR OTHERWISE ENTER OR SWIM IN ANY PORTION OF THE NEARSHORE OCEAN AREA OUTSIDE THE PROTECTED OCEAN SWIMMING AREA. THE PROVISIONS OF THIS SECTION SHALL NOT BE APPLICABLE TO WATER AREAS OF THE NEARSHORE OCEAN AREA WITHIN THE HARBOR DISTRICT OF THE CITY OR TO CITY EMPLOYEES PERFORMING AN OFFICIAL DUTY. 16.12.180

NO PERSON SHALL THROW, DISCHARGE, DEPOSIT OR LEAVE ANY REFUSE, SEWAGE, OIL OR WATER MATTER OF ANY DESCRIPTION UPON OR INTO THE WATERS OF THE NEARSHORE OCEAN AREA, AND NO PERSON SHALL DISCHARGE OR DEPOSIT MATERIAL OF ANY KIND ON THE BANKS, WALLS, SIDEWALKS OR BEACHES THAT BORDER THE NEARSHORE OCEAN AREA WHERE SUCH MATERIAL MAY BE WASHED INTO THE WATERS OF THE NEAR SHORE OCEAN AREA BY TIDES, STORMWATERS OR OTHERWISE. ANY PERSON THAT INTENTIONALLY OR NEGLIGENTLY CAUSES OR PERMITS ANY OF SAID SUBSTANCES TO BE DEPOSITED OR DISCHARGED INTO THE WATERS OF OR UPON A BANK, SIDEWALK, SEAWALL, WHARF, WHARF ROAD, STREET LEADING TO A WHARF, FLOAT, PIER, HARBOR STRUCTURE OR BEACH OF THE NEAR SHORE OCEAN AREA SHALL BE CIVILLY LIABLE TO THE CITY FOR ALL ACTUAL DAMAGES IN ADDITION TO THE REASONABLE COSTS ACTUALLY INCURRED IN THE CLEANING OR ABATING ACTIVITIES. 16.12.260

SPECIAL CONDITIONS:

All Open Permit Users agree and understand that the granting of permission to use and occupy anchorage/mooring at ISLAND WHITE does not and shall not be construed as the grant, conveyance or transfer of an interest in real property; that neither this open permit nor any interest herein may be transferred except in accordance with the provisions of the Long Beach Municipal Code and the Long Beach Marina Rules and Regulations, and that the use and occupancy of slip/mooring at ISLAND WHITE may be terminated by the Manager of the Marine Bureau after notice of failure to observe and comply with the provisions of the Long Beach Municipal Code and the Rules and Regulations, policies and procedures ("applicable regulations") governing and controlling the administration and operation of the Long Beach Marinas. User further acknowledges that he/she has read and understands the applicable regulations and that the applicable regulations are subject to change. Open permit user in his/her use and occupancy of the assigned slip/mooring, agrees to comply with and be bound by the applicable regulations now in force and as hereafter changed. The open permit user certifies that the situs of his/her vessel is and shall be the City of Long Beach.

Waiver: Open Permit Users waive all claims for damage to persons and/or property sustained by Open Permit User on or about Open Permit User's vessel or within the Long Beach Marina system resulting from oil operations conducted on Island White, and neither the City of Long Beach nor any of its officers, employees, or contractors shall be liable for any such claim for damage to persons and/or property. All property belonging to Open Permit User shall be there at the risk of the Open Permit User, and the City shall not be liable for damage thereto nor theft or misappropriation.
